- 3. Submissions are to be no longer than two A4 pages (plus testimonial / reference)
- 4. Submissions are to be written in Arial 12 point and submitted in word.
- 5. Submissions must include a photo for publication.

- 7. The judging panel will review all entrant submissions.

The Strata Community Management Business (Small) Award for 2019 recognises a small scale strata community management business (less than 2000 lots under management) that has devised and implemented strategies for service excellence and sustainable growth and profitability over the last 12 months

## Eligibility:

- The Business must be a current SCA Management Member
- Must employ at least 1 SCA Accredited strata community manager
- Must not have a Code of Conduct complaint upheld against any employee over the last 12 months
- The directors of the company must not have had a conviction for a summary or indictable offence
- The winner of this award category will progress to the SCA Australasian Awards as a Finalist subject to meeting the T&Cs.

## Strata Community Management Business (Large) Award 2019

The Strata Community Management Business (Large) Award for 2019 recognises a large scale strata community management business (over 2000 lots under management) that has devised and implemented strategies for service excellence and sustainable growth and profitability over the last 12 months

## Eligibility:

- The Business must be a current SCA Management Member
- Must employ at least 1 SCA Accredited strata community manager
- Must not have a Code of Conduct complaint upheld against any employee over the last 12 months
- The directors of the company must not have had a conviction for a summary or indictable offence
- The winner of this award category will progress to the SCA Australasian Awards as a Finalist subject to meeting the T&Cs.







## Strata Community Manager Award 2019

The Strata Community Manager 2019 Award for 2019 recognises a strata community manager who has demonstrated entrepreneurial spirit, business acumen and innovative ideas.

### Eligibility:

- Must have been practising as a strata community manager for 2 years or more
- Must be a nominee of a current SCA Management Member
- Must be an SCA Accredited strata community manager
- Must not have a Code of Conduct complaint upheld against them over the last 12 months
- If employed in a business, must have been continuously employed for the previous 12 months
- The winner of this award category will progress to the SCA Australasian Awards as a Finalist subject to meeting the T&Cs.
- May be nominated by a colleague/employer or self

## Strata Community Manager Rising Star Award 2019

The Strata Community Management Rising Star Award for 2019 recognises a new entrant to the industry who has shown outstanding early progress in their career.

#### Eligibility:

- Must have been practising as a strata community manager for 2 years or less
- Must have been employed with their current employer for not less than the last 12 months
- Must be a current Nominee of an SCA Strata Management Member
- Must not have a Code of Conduct complaint upheld against them over the last 12 months
- The winner of this award category will progress to the SCA Australasian Awards as a Finalist subject to meeting the T&Cs.
- May be nominated by a colleague/employer or self.







## **Support Team Member Award 2019**

The Support Team Member Award for 2019 recognises a person behind the scenes who has made an outstanding contribution to the success of their team.

## Eligibility:

- Must be a nominee of a current SCA Management Member or Services Member.
- Must have worked for their current employer for at least the past 12 months
- Cannot be currently employed as a strata community manager
- Must not have a Code of Conduct complaint upheld against them over the last 12 months
- The winner of this award category will progress to the SCA Australasian Awards as a Finalist subject to meeting the T&Cs.
- May be nominated by a colleague/employer or self

## Ann Shevill Essay Award 2019

The Ann Shevill Essay Award is in honour of the late Life Member Ann Shevill who engaged in the strata sector from its inception in the mid-80ies until her passing in 2014. Ann was a spirited, highly engaged and passionate pioneer in founding a professional organisation that provides education and advocacy.

The Essay (maximum 1000 words) must demonstrate interest in the strata sector and be topical to current issues or take an unusual view. The essay can be informative or humorous but must be an original work and must display;

- An understanding of your chosen topic and its relevance to the strata community industry
- An ability to communicate effectively through the written word medium
- Proper grammar and spelling

## Eligibility:

- Entry is open to nominees of current Manager Members, current Services members and current Lot Owner members
- Must not have a Code of Conduct complaint upheld against them over the last 12 months
- The winner of this award category will progress to the SCA
  Australasian Awards as a Finalist subject to meeting the T&Cs.
