Declaration to the SCA (Qld) Board

I hereby request that my application for corporate membership with SCA (Qld) be accepted by the SCA (Qld) Board of Directors. I accept the following membership conditions and hereby declare on behalf of the above mentioned company that:

- The company carries professional indemnity insurance as prescribed by the Board. The current prescribed minimum for professional indemnity insurance is \$2million on any one claim (proof provided to SCA (Qld));

 - (iii) a compromise or arrangement of the kind referred to in part 5.1 of the Corporations Act proposed;
 - (iv) an application made or an action is initiated with a view to cancelling its registration or appointing an inspector or other officer to investigate any of its affairs pursuant to any legislation;
 - (v) been deemed under any applicable law to be, insolvent or unable to pay its debts; or
 - (vi) circumstances exist which would enable the court upon application to order its winding up pursuant to section 461 of the Corporations Act
- Neither the company nor any of its Directors must not have been convicted of an offence involving dishonesty;
- The company is and was not in receivership or administration or declared bankrupt at any time;
- I agree to be governed by the Constitution of SCA (Qld) Ltd (ABN 151 638 819 27);
- I confirm that myself and all staff registered from my company endeavour to abide by the SCA Code of Ethics and any other Standards prescribed by SCA (Qld);
